What is this Product?

Type

This is the DKK W R Share Class of the Securus Fund, which belongs to the Sparinvest SICAV umbrella Fund – an open-ended investment fund.

The Share Class is accumulating, meaning that any income generated by the Fund is reinvested.

The reference currency of the Fund is EUR and the currency of the Share Class is DKK.

Term

The Fund has no maturity date.

The Share Class can be terminated if the net asset value is below EUR 5 million or if a change in the economic or political situation would justify such liquidation of if necessary in the interests of the shareholders.

Investment Objective and Policy

The Fund aims at providing a positive return over the medium term.

The Fund invests at least 55-90% of its total net assets in fixed income transferable securities and 5-40% of its total net assets in equities and/or equity-equivalent securities (such as ADR/GDR).

The Fund invests more than half of its total net assets in developed markets investment grade government and Danish covered bonds, and up to 30% of its total net assets in rated corporate bonds (investment grade corporate bonds or high yield corporate bonds), emerging markets sovereign bonds (investment grade or high yield) and/or non-rated bonds.

The Fund may invest up to 10% of its total net assets in China A-Shares via the China-Hong Kong Stock Connect and China B-Shares.

The Fund may, to a limited extent, invest in convertible securities, contingent convertibles (less than 5% of the total net assets) and warrants on transferable securities.

The Fund may invest in liquid assets and/or regularly traded money market instruments with a residual term of a maximum of 12 months.

The Fund may, to a limited extent, invest in other funds, including closed-end funds with alternative strategies.

The Fund can hold up to 15% in cash. There is no limitation in terms of currency of investments. The Fund may invest in all regions, including up to 30% of its total net assets in emerging markets. The Fund may use derivatives to protect the portfolio against currency fluctuations.

Environmental and social characteristics as well as good governance of the companies invested into are taken into consideration when making investment decisions.

The Fund promotes environmental and social characteristics, but does not have sustainable investment as an objective. Therefore, the Fund falls under the category of Article 8 SFDR.

Benchmark: BM - Mix Low.

BM - Mix Low comprises the following indices: MSCI ACWI (25%), Nykredit CM Government Bonds 5Y (37.5%), Nykredit Constant Maturity Index CM3 (37.5%).

The Fund is actively managed and references a benchmark for asset allocation, risk measurement and comparative purposes. The Investment Manager has full discretion over the composition of the portfolio of the Fund even though the benchmark constituents are generally representative of the Fund's portfolio. The Fund does however not track the benchmark and can invest in instruments that are not constituents of the benchmark. The degree to which the composition of the Fund's portfolio may deviate from the benchmark will vary over time and the Fund's performance may be meaningfully different from that of the benchmark.

Intended investor

This Share Class is available to all investors that do not meet the criteria as laid out in Annex II of the MiFID II Directive (2014/65/EU).

The Fund is aimed at investors with a short to medium-term investment horizon and with a medium-risk profile. Investors must be aware that they might not recover the initial investments. Investors should consider their long-term investment goals and financial needs when making an investment decision.

The Fund may not be appropriate for investors who plan to withdraw their money within 3 years.

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets. The risk category is not guaranteed and may change over time.

This product has been classified as 2 out of 7, which is the a low risk class. This means that the risk of potential losses from future performance is low. Poor market conditions could reduce the value of your investment.

Be aware of currency risk. If your currency used for investing is different from the Share Class currency, the final return will depend on the exchange rate between the two currencies on the date of trade. This risk is not taken into consideration in the indicator shown above.

Performance Scenarios

Future market performance will determine the return from this Product. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown in the table below are illustrations using the worst, average, and best performance of the Fund over the last 10 years. Markets could develop very differently in the future.

What happens if Sparinvest SICAV is unable to pay out?

The Fund's assets are safeguarded by the Depositary. However, in the event of the Depositary's insolvency, the Fund may suffer a financial loss. Since the Depositary is required by law to segregate its own assets from the assets of the Fund, this risk is however mitigated to a certain extent.

What are the costs

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the Fund and how the Fund performs. We have assumed that, in the first year, you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the Fund performs as shown in the 'moderate' scenario.
